Board Reports

Treasurer's Report

Bridget Darling presented the statement of activity for the month of August 2025. \$1100 was raised for Girls Inc. at the August meeting. \$900 was brought in for membership. \$241 was from merchandise sold. The gross profits for August were \$2286.00 with the expenses totaling \$3925.55.

Vice Presidents Report

The September meeting at 810 went well, we plan to be back for the April 2026 meeting. We are all set for the next gathering at Papa Joe's. Dave will check on WIFI availability for that gathering. The Island trip is set for Sept. 20th.

Secretary's Report

Charity Mal Report

Jodi West let the group know that a memorial wreathe will be at The Dock for the October 3 meeting. She will have basket pictures for that meeting soon. She reported on a potential new charity Maritime Academy. They are a charter school and a 501c3. Jodi took a tour of the facility and presented the courses and certifications the school offers. Old Business
