Call to order

The meeting was called to order at 3:57PM

Board Members present: Dave Knight, Cheryl Furr, Jodi West, Bridget Darling, and Sherri Dabney. Jenni Graber and Joe Alexander were absent. Quorum was met.

Approval of minutes

Cheryl Furr moved that the minutes be approved, it was seconded by Sherri Dabney. The minutes of the September 2025 meeting were adopted.

Board Reports

Treasurer's Report

Bridget Darling presented the statement of activity for the month of September 2025. A total of \$1467 was raised for charities in September. \$2100 was brought in from membership. \$655 in merchandise was sold. Parade income was \$1120. Total income for September was \$5349. Our expenses for September were \$5853.38 with \$3272.50 coming from Rendezvous expenses and \$1000 to Trop Rock Radio. Our beginning balance was \$7004.63 with an ending balance of \$5947.95.

Vice Presidents Report

The October meeting at The Dock with String Theory went well, we had a good turnout.

Dave asked if you have suggestions for venues or bands, let him know.

Secretary's Report

A get-well card was sent out to the one of our members. Cheryl was asked to send two cards out – a condolence and a get-well card. Cards being sent out are being tracked on a spreadsheet.

Charity MaL Report

The charity for January will be Beach Services; there are no charities scheduled for November or December. Jodi West let the group know more about AMI. They reached out and said their funding comes from grants and fund raisers. There are 65 students at the school who are currently in need to computers. Jodi made a motion at add AMI to our list of charities, it was seconded by Sherri, the motion passed. Currently we have 19 charities on our list.

Membership MaL Report

Sherri Dabney said we have added 52 members and 89 added since the board took over, for a total of 516 members. The website has been updated. The Halloween party has been posted to Facebook. We will have brochures available for new potential members at the next meeting.

Merchandise MaL Report

Bridget reported that several members asked about Rendezvous magnets, the cost would be \$5.35 if we ordered 25. Jenni is looking at zip up hoodies. She will need to replenish merchandise later. It was suggested that we sell Rendezvous Christmas ornaments.

Old Business

a. Visual Display Board

It was shown at the October meeting, everyone thought it looked great. Sandy has been helping put it together. Jodi would like to find a cork board or something that would be sturdier. She will look at the skill list for those with marketing experience for additional volunteers. The membership form has been fixed where new members must add a skill.

b. Sims Vet Center

The BBQ is set for Nov. 11th at noon. SIMS is also holding a Veterans ceremony at 10AM if anyone would like to attend it as well. Majors Smokehouse is providing the meat, with SIMS providing the sides. WJHG has been contacted. Gino has volunteered to sing. We requested a \$500 donation from Tyndall, plus we have the donation from Margaritaville cottages for the raffle.

Dave made a motion that we give 810 shirts from Rendezvous for their servers to wear on Parrot head nights. Bridget seconded the motion which passed.

Dave also made a motion that we take the remainder of the Rendezvous shirts and donate them to SIMS. Jodi seconded the motion which passed.

Dave made another motion that whatever monies remain be donated to SIMS to be used for them to participate in the Christmas parade. Bridget seconded the motion which passed.

c. Long Term Member Recognition

The club will begin recognizing members who have 20 years or more with the club.

d. Beach Clean up

We didn't fill the boat but had about 40 members present. The clean-up was successful. Dave will check on potentially holding the clean-up twice a year.

e. Volunteer Hours

This was tabled until the next meeting.

f. Rendezvous Update

271 tickets have been sold. We will advertise tents go on sale beginning Nov. 1. We looked into a local member doing our shirts but they were cost prohibitive thus we will use the same vendor as last year out of Atlanta. He will make us a good deal on the Tye dyed shirts. We will let him know shirts must arrive no later that April 1.
