Call to order

Dave Knight moved that the minutes be approved, it was seconded by Jodi West. The minutes of the October 2025 meeting were adopted.

Board Reports

Treasurer's Report

Bridget Darling presented the statement of activity for the month of October 2025. A total of \$1160 was raised for charities in October. \$1320 was raised from the raffle. \$1200 was brought in from new and renewals of membership. \$225.53 in merchandise was sold. Parade income was \$605 with a total spend of \$2,608.57 of which \$1,291.37 were repairs made to the float.

Income from the Christmas party is \$993.10.

Rendezvous income is at \$41,131.35 expenses were \$9,860.56.

Total income for October was \$45,744.59, with a net income of \$35,884.02.

Our beginning balance was \$5,947.95 with an ending balance of \$42,438.89.

Bridget made a motion that we carry over \$15,000 next year, Jodi seconded the motion which passed.

Vice Presidents Report

The Veterans Day BBQ at SIMS had a good turnout. The Club also presented SIMS With a check for \$795 raised from the club's raffle. It was proposed that we make a certificate to our sponsors along with a thank you card from the board to show our appreciation for their support. WJHG TV station was on hand and did a story on the event.

Secretary's Report

A get-well card was sent out to the one of our members' post-surgery. Currently 5 cards have been sent to members since August 2025.

Charity MaL Report

Jodi West presented a tri-fold board which will be used at the monthly meetings. It is better quality materials than the one currently being used and can last for several years. The cost of the board with tax is \$128.59.

Jodi made a motion to purchase the board; Dave Knight seconded the motion which passed.

Jodi has been approached by Salty Farms Ministry; Jodi will add them to the Charity list. Dave Knight reminded the Board that Wreathes Across America is in need of volunteers on Dec. 13th to lay wreathes. This will be posted for anyone who would like to participate.

Membership MaL Report

Sherri Dabney was not present but Bridget said we had 11 new members for October and 3 new members so far for November. We have a total of 496 members.

Merchandise MaL Report

Bridget reported that Jenni has created a Parrot Head Christmas ball. The cost of the balls is \$6 each and they will be sold for \$10. Bridget made a motion to order 25 balls that can be sold at the Christmas party.

Dave Knight seconded the motion which passed. Merchandise has brought in \$1,402.63 through November and has spent \$851.06

Old Business

a. Christmas Party

The Party is at Dirty Dicks on Dec. 5th at 5:30PM. Tickets are \$25 and members are asked to bring an unwrapped toy. Jeff will be playing at the event. We have sold 69 tickets to the event. Decorating will begin at 1pm. Sandy has purchased table clothes and is looking at poinsettias for the center pieces. Dave Knight made a motion to approve up to \$500 for decorations which was seconded by Jodi. The motion passed.

b. Volunteer Hours

Joe Alexander reached out to Jimmy about tracking but has not heard back from him yet.

c. Rendezvous Update

372 tickets have been sold. We have sold 52 tents thus far. Tent sales will open to the public on December 1.

New Business

a. Member Survey
